

SUMMARY ANNUAL REPORT

For VANDERBILT UNIVERSITY RETIREMENT PLAN

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan for VANDERBILT UNIVERSITY RETIREMENT PLAN, EIN 62-0476822, Plan No. 001, for period January 1, 2023 through December 31, 2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single-employer defined contribution plan.

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$153,205,636. These expenses included \$566,787 in administrative expenses, and \$152,638,849 in benefits paid to participants and beneficiaries. A total of 22,184 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$2,316,024,751 as of December 31, 2023, compared to \$2,069,951,170 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$246,073,581. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$399,279,217, including employer contributions of \$24,987,587, employee contributions of \$54,972,999, earnings from investments of \$288,953,861, and other income of \$30,364,770.

The plan has contracts with Principal Life Insurance Company, Tiaa-Cref, Variable Annuity Life Insurance Co. and Variable Annuity Life Insurance Co.. The total premiums paid for the plan year ending December 31, 2023 were \$0.

administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
