W-2 forms are scheduled to be mailed on or after Jan.31 to employee home addresses. You can also view your W-2 on Oracle Jan. 31. The online W-2 has the same information as the mailed W-2. Please use Oracle to reprint your W-2.

What is a W-2?

It's a snapshot of how much Vanderbilt has paid you throughout the year, how much tax we've withheld from your paycheck, and other payroll withholdings that can affect your tax obligations. Your W-2 is broken into three main sections: personal information, wages and federal taxes information, and state and local taxes.

 E Voluntary Pre-tax Contributions to 403(b) -- includes voluntary employee retirement contributions; mandatory contributions are NOT included in this
 - T Adoption assistance benefits provided by Vanderbilt
 - BB Voluntary Roth Contributions to 403(b) -- includes all voluntary employee retirement contributions
 - DD Reporting Employer Provided Health Coverage reporting the cost of medical coverage (employee and employer portions).
 - W Employer and Employee Contributions to Health Savings Account (HSA)

Guidelines for other codes that may appear are explained on the back of the W-2.

- Box 13: Retirement Plan this box is checked if you are enrolled in the Union Pension Plan or make mandatory or voluntary 403(b) retirement contributions
- Box 14: This box reports some miscellaneous information including (but not limited to): Taxable Auto personal use of Vanderbilt-provided automobiles Taxable Tuition taxable tuition benefits paid to you, or on your behalf
