

## **SUMMARY ANNUAL REPORT**

### **VANDERBILT UNIVERSITY WELFARE BENEFIT PLAN**

This is a summary of the annual report of the VANDERBILT UNIVERSITY WELFARE BENEFIT PLAN, EIN 62-0476822, Plan No. 513, for period January 01, 2020 through December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has contracts with Hartford Life And Accident, First Unum Life Insurance Company, Bluecross Blueshield Of Tennessee, Inc., Cigna Health And Life Insurance Company And Affiliates, Unum Life Insurance Company Of America, Metropolitan Life Insurance Company, Metropolitan Life Insurance Company, Unum Life Insurance Company Of America and National Guardian Life Insurance Company to pay dental, vision, life insurance, temporary disability, long-term disability, indemnity, BUSINESS TRAVEL ACCIDENT and ADD claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2020 were \$7,032,416.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2020, the premiums paid under such "experience-rated" contracts were \$2,225,795 and the total of all benefit claims paid under these contracts during the plan year was \$1,741,946.
